How To Schedule Your FLORIDA INSURANCE EXAM

You can schedule your Florida insurance exam at any time. Completion of the pre-licensing course is NOT required in order to schedule the test. Our recommendation is to take the state exam 5-10 days AFTER you've completed your course. Scheduling can be completed by calling **1.888.274.2020** or on the PearsonVue website by following the steps below.

STEP 1 Create an Account or Sign In

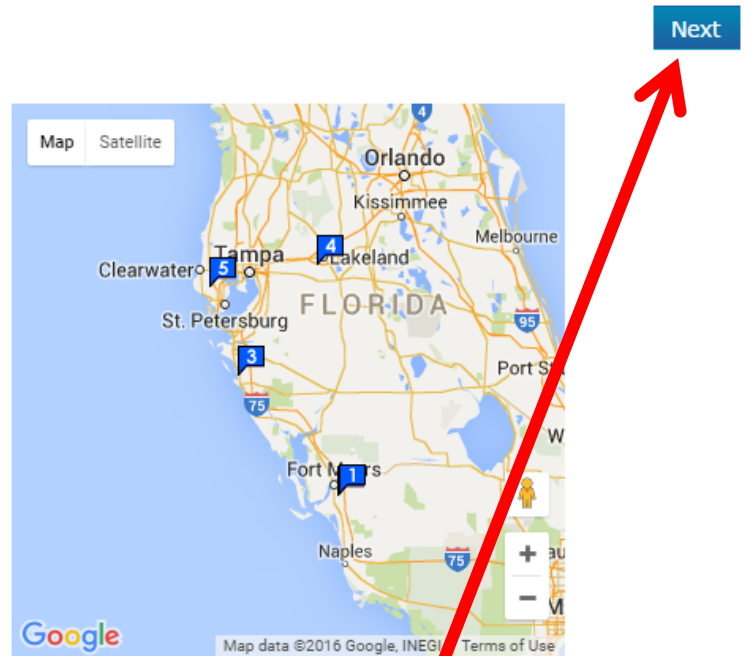

Additional PearsonVue Exam Information

We ask that you arrive at the test center 30 minutes before your scheduled appointment time. This will give you adequate time to complete the necessary sign-in procedures. If you arrive more than 15 minutes late for an exam and are refused admission, exam fees will be forfeited.

ITEMS YOU WILL NEED TO BRING:

Candidate must present one (1) form of current unexpired signature identification. The name on the identification must exactly match the name on the registration. The identification must be in English, government issued, photo-bearing with a valid signature.

The candidate's identification and other documentation will be reviewed and they will be photographed for the score report. No personal items may be taken into the testing room. This includes all bags, books not authorized by the sponsor, notes, phones, pagers, watches and wallets.

Reschedule Policy

*If you wish to reschedule your exam, you must contact Pearson VUE at least 48 hours prior to your exam appointment date. Rescheduling an exam less than 48 hours prior to your exam date is subject to forfeiture of your exam fee. No shows are also subject to forfeiture of the exam fee.

Cancellation Policy

*If you wish to cancel your exam, you must contact Pearson VUE at least 48 hours prior to your exam appointment date. Canceling an exam less than 48 hours prior to your exam date is subject to forfeiture of your exam fee. No shows are also subject to forfeiture of the exam fee.

REVIEW OF EXAMS

Candidates may review an examination they have failed by contacting Pearson VUE at (888) 274-2020. There are no fees for this review, although candidates must request and complete examination reviews within ninety (90) days of the original examination date. Only the last examination the candidate took, along with the answers he/she gave, is available for review. Candidates may not review an examination more than once.
